The balance is due in (45) days prior to the prom date. If the balance is not paid in (45) days prior to the prom date, the deposit will be forfeited and the limousine will be rescheduled with another customer from our waiting list. The total for this contract is \$____ and is for the time frame of _____ to _____. Any time over this (with a fifteen minute grace period) will be charged at _____ per hour in thirty-minute increments. This limousine is contracted for up to 22 passengers and no more. I will be responsible for my minor child, as well as the other minor children using the service. I will be responsible for any irregular behavior by the children, and I agree that there no alcoholic beverages or other prohibited substance will be brought in the vehicle. I am fully aware that upon any infraction of this agreement any and all monies shall be forfeited. The limousine is inspected by the driver before the trip and if desired, by the parents at the first pick up location. If the limousine is damaged in any way the signing parties will be responsible for the cost of repairs.

Passenger's Agreement For Prom Service

The consumption of any alcoholic beverages or tobacco product is unlawful when consumed by a minor. There will be no alcoholic beverages transported in the passenger compartment or any other compartment of the limousine. There will be NO SMOKING in the limousine. This rule shall apply to any and all other illegal substances. If, at anytime, any of the passengers are found to have in their possession, or have been at anytime during the course of the service, been consuming any alcohol or an illegal substance the *service shall be terminated*. Any and all monies shall be forfeited and the parent shall be notified. The driver has the option of returning to the point of pick up or ending the service at the point of infraction. The driver shall also have the right to examine all bags or parcels to be placed in the vehicle to determine if they contain any illegal substances. Due to high-risk insurance factors, standing up through the moon roof will only be permitted while the car is parked in a driveway or parking lot.

A separate signature of all passengers is required to ride in the vehicle. Also please print your full name immediately to the right.

* Deposits are non refundable If cancellation is made prior to the date of prom ,there will be no refund of any deposits put down on the contract if cancellations not made at least forty five days prior to the date vehicle is committed for the individual who signs the contract will be liable for entire balance of the contract in full Cancellations over the phone are not valid Long Beach Limousine must receive all cancellations in writing only at least forty five days prior to the date of service All cancellations are only valid if made by the person who` s name appear on the contract only

* Absolutely no alcoholic beverages or illegal drugs are to be stored or consumed in the passenger cabin or trunks of the vehicles All of our vehicles are non -smoking vehicles . There is absolutely no smoking in any vehicle hired from LONG BEACH LIMOUSINE There will be no exceptions extended to anyone

* Any and all damages that may occur in the passenger cabin of the limousine will be the sole responsibility of the person who hired the limousine and whom signs this agreement. There will be also be additional charge of \$200 for cleaning the cabin of the vehicle ,if a student become sick(vomits) in the cabin of the limousine

* The balance is due on cash, certified check , personnel check one month prior to prom date. Credit cards are not accepted as a final payment at all They may be accepted as a deposit only .There will be no exceptions for anyone on the day of service Checks payable to LONG BEACH LIMOUSINE& TRAVEL INC .

Your chauffeur is a professional , who will assist you with any and all questions you might have . You will be treated with the outmost respect , as we expect you to treat your chauffeur. Your chauffeur is directed by this management to terminate service immediately .without refund ,if there is drinking of alcoholic beverages use of illegal drugs .All travel time and tolls are additional to the total amount of this contract

* If cancellation is made by the customer ,there will be no refund of discretion of Long Beach Limousine whether or not to supply a replacement vehicle If cancellation is made by the customer , there will be no refund of deposit and if cancellation is not made 45 days of service. The undersigned will be liable for full payment of order and any legal fees, if necessary .

* All students will be required to show a driver license when booking The limousines unless a parent is present to sign the contract
